- clearly articulate the College's expectations regarding the responsible behaviour plan for students and the College's dress code policy
- ensure that the parent is aware of the College's record-keeping policy including the creation of a transfer note should the student enrol at another College
- set, mark and monitor homework regularly in keeping with the College's homework policy
- contact parents and carers as soon as is possible if the College is concerned about the child's College work, behaviour, attendance or punctuality

- consult parents on any major issues affecting students
- treat students and parents with respect and tolerance.
